

List of items prohibited from the Russian Investment Forum 2019 venue*

No.	Prohibited items	Exceptions
1	Explosives and related components, detonators, and items containing explosives	
2	Weapons of any sort, including weapons for self-defence, ammunition, firearms components, and riot control weapons	
3	Piercing or cutting objects, knives, other bladed weapons, and any object that could be used as a weapon	
4	Any objects resembling prohibited items, or copies and equivalents thereof	
5	Any means of disguise/camouflage, or items hindering personal identification	
6	Aerosols, compressed or liquefied gas	Pocket lighters
7	Flammable and pyrotechnical substances or products, signal flares, hand flares, firecrackers, gas cylinders, and items/chemical materials which could be used to create pyrotechnical objects or smoke	Matches
8	Non-pyrotechnical devices and products (including self-made) which are used to disperse or spray various materials and substances (including pneumatic poppers) and other substances, products, or items (including self-made) capable of causing injury, combustion, or smoke	
9	Highly flammable solids, liquids, or gases	
10	Oxidizing agents and organic peroxides	
11	Toxic substances, radioactive materials, and corrosive substances	
12	Poisonous, noxious, and strong-smelling substances	
13	Materials of an extremist, offensive, or discriminatory character that incorporate Nazi paraphernalia or symbols, or paraphernalia or symbols of any other extremist organizations, or intended to in any way discriminate against a country, an individual or a group of individuals on the grounds of race; skin colour; ethnic, national or social origin and status; birthplace; financial or any other status; sex; disability; language; religion; political or any other opinions, including but not limited to banners, flags, symbols, paraphernalia, leaflets, and clothing

15	Narcotic, psychotropic, and toxic substances and their precursors, including in the form of medicines, as well as medical syringes and needles for injections	Injectable drugs, medical syringes, and needles, if medical documents are presented showing that they are essential
16	Glass and metal containers, bottles, and jars	Transparent plastic food containers of up to 1.5 litres in volume
17	Liquids in containers larger than 500ml	
18	Alcoholic beverages	
19	Any animals	Guide dogs with a passport and completed veterinary document
20	Bulky items where the sum of the length, width, and height measurements exceeds 150cm	
21	Flags and banners larger than 2m x 1.5m in size	Flags up to 2m x 1.5m in size, if made exclusively from non-flammable materials
22	Flagpoles for flags or posters of any kind	Flexible plastic or double flagpoles (up to 1m in length)
23	Advertising materials of any kind, and any printed materials with religious, political, or offensive content or content that poses a threat to public order and/or decency (including banners, placards, posters, signs, and equivalent items)	Religious books for personal use
24	Equipment that could interfere with the running of Forum events	
25	Moving and gliding aircraft and related models (gliders, drones, kites, etc.)	
26	Any granular substances, regardless of quantity	Permitted medicines in powdered form
27	Any other hazardous substances and objects, as well as items prohibited from distribution within the Russian Federation
